# The School Premises (General Requirements and Standards) (Scotland) Amendment Regulations 1973

In exercise of the powers conferred on me by section 2 of the Education (Scotland) Act 1962(a) as set out in section 1(1) of the Education (Scotland) Act 1969(b), and by sections 19(1), 20(1A)(b), 76(1) and 144(5) of the said Act of 1962, as amended by the said Act of 1969, and of all other powers enabling me in that behalf, I hereby make the following regulations:—

Citation, construction and commencement

- 1.—(1) These regulations may be cited as the School Premises (General Requirements and Standards) (Scotland) Amendment Regulations 1973, and the School Premises (General Requirements and Standards) (Scotland) Regulations 1967(c) (hereinafter referred to as "the principal regulations") and these regulations shall be construed as one and may be cited together as the School Premises (General Requirements and Standards) (Scotland) Regulations 1967 and 1973.
  - (2) These regulations shall come into operation on 1st April 1973.

Amendment of regulation 3 of the principal regulations

- 2. In regulation 3 of the principal regulations for paragraph (7) there shall be substituted the following paragraph—
  - "(7) "school" means a public school or a grant-aided school and includes a nursery school and a special school, but does not include an establishment or residential establishment within the meaning of the Social Work (Scotland) Act 1968(d), or an independent school.".

Amendment of regulations 4 and 5 of the principal regulations

3. In the principal regulations, for regulations 4 and 5 there shall be substituted the following regulation—

(d) 1968 c. 49.

- "Cases excepted from requirements of section 20(1A)(b) of the Act of 1962
- 4. Works for the erection, extension or alteration of any school building shall be excepted from the requirements of section 20(1A)(b) (which requires the written approval of the Secretary of State before the commencement of the works therein specified) of the Act of 1962: provided that the cost of the works shall not exceed £25,000. In this regulation the expression "cost", in relation to any works means the cost of building and does not include any cost incurred in respect of professional fees, furniture or equipment.".

Amendment of regulation 7 of the principal regulations

- 4. In regulation 7 of the principal regulations—
  - (a) in paragraph (1) for the word "Every" there shall be substituted the words "Subject to paragraph (4) of this regulation every";
  - (b) in paragraph (3) for Table III there shall be substituted the following Table—

- (c) for paragraph (4) there shall be substituted the following paragraph—
  - "(4) Paragraph (1) of this regulation in its application to a primary school with a nursery class or classes shall have effect subject to the addition to the area specified therein of 0.075 hectares where the number of nursery pupils is 20 or less and where the number of nursery pupils is more than 20, of 0.025 hectares for each additional 10 nursery pupils."

Amendment of regulation 8 of the principal regulations

- 5. In regulation 8 of the principal regulations—
  - (a) in paragraph (1) for the word "Every" there shall be substituted the words "Subject to paragraph (2B) of this regulation every";
  - (b) after paragraph (2) there shall be inserted the following paragraphs—
    - "(2A) Every nursery school and every nursery class in a primary school shall have available and in close proximity to it a garden playing space of not less than an area of 9.3m<sup>2</sup> per pupil of which a minimum area of 3.7m<sup>2</sup> per pupil shall be paved.
    - (2B) Paragraph (1) of this regulation in its application to a primary school with a nursery class or classes shall have effect as if for the

word "pupils" there were substituted the words "pupils, other than nursery pupils.".

Amendment of regulation 12 of the principal regulations

- 6. For regulation 12 of the principal regulations there shall be substituted the following regulation—
  - "Playroom accommodation in nursery schools and classes
  - 12. Every nursery school and every nursery class in a primary school shall include playroom accommodation of not less than the area specified in Table VIIA according to the number of pupils for which the school or class is designed.

Amendment of regulation 15 of the principal regulations

- 7. In regulation 15 of the principal regulations—
  - (a) in paragraph (1) for the words "In every" there shall be substituted the words "Subject to paragraph (1A) of this regulation, in every" and after the words "Provided that" there shall be inserted the words ", except where paragraph (1A) of this regulation applies,";
  - (b) after paragraph (1) there shall be inserted the following paragraph—
    - "(1A) Every nursery school and every nursery class in a primary school shall have not less than 1 water closet for every 10 pupils.";
  - (c) for paragraph (4) there shall be substituted the following paragraph—
    - "(4) In every school every water closet shall be provided with a partition sufficient to secure privacy and, except in relation to a nursery school or nursery class in a primary school, with a lockable door.".

Amendment of regulation 21 of the principal regulations

- 8. In regulation 21 of the principal regulations for paragraph (7) there shall be substituted the following paragraph—
  - "(7) In this regulation the words "candela", "illumination", "light", "luminance" and "lux" shall have the meanings attributed to them in Part 4,

Group 01, of the Glossary of Electrotechnical, Power, Telecommunication, Electronics, Lighting and Colour Terms, published under the authority of the Executive Board of the British Standards Institution in April 1971.".

Amendment of regulation 26 of the principal regulations

9. In regulation 26 of the principal regulations for the words "Part II" there shall be substituted the words "(a) section 20(1A) of the Act of 1962 as it applies to an education authority, and (b) Part I".

Amendments to principal regulations substituting metric for existing measures

- 10. In the regulations of the principal regulations specified in column (1) of Schedule 1 to these regulations for the existing measures specified opposite such regulations in column (2) of the said Schedule there shall be substituted the metric measures so specified in column (3) of said Schedule.
- 11. For the Tables I-II, IV-VII and X set out in the principal regulations there shall be substituted the Tables I-II, IV-VII and X respectively set out in Schedule 2 to these regulations.

## **EXPLANATORY NOTE**

(This Note is not part of the Regulations.)

The Regulations amend the School Premises (General Requirements and Standards) (Scotland) Regulations 1967. The principal amendments are as follows—

- 1. Regulation 3, (a) deletes regulations 4 and 5 of the 1967 regulations (which relate to approval by the Secretary of State of sites and proposals for school buildings etc.) in consequence of the amendment of the provisions of section 20 of the Education (Scotland) Act 1962 by the Education (Scotland) Act 1969 and (b) provides that education authorities may proceed with work on the erection, extension or alteration of school buildings under section 20(1A)(b) of the Act of 1962 without the prior approval of the Secretary of State where the building cost of such work does not exceed £25,000.
- 2. Regulations 4 to 6 amend and extend the minimum area standards prescribed for nursery schools and classes. Regulation 4 also alters the site standards for primary schools.
- 3. Regulation 7 inserts specific provision in regulation 15 of the 1967 Regulations in relation to sanitary accommodation for nursery schools and classes.
- 4. Regulation 9 amends regulation 26 of the 1967 Regulations so as to apply section 20(1A) of the Act of 1962 to grant-aided schools consequent upon the deletion of regulations 4 and 5 of the 1967 Regulations.
- 5. Regulations 10 and 11 and Schedules 1 and 2 substitute metric measures for the existing measures in the 1967 Regulations.
